Dear friends, colleagues and partners,

August and September of 2021 were record months for the Business Ombudsman Council in terms of business complaints. During two months, we received 429 complaints on malpractice of state bodies – the largest number in the last three years. As compared to the same period of 2020, in August-September 2021, entrepreneurs filed 40% more appeals. We proceeded with 262 complaints and completed investigation of 253 cases – half more than in August-September 2020.

During these two months, I met with the Polish community twice: in Warsaw at Polish-Ukrainian Economic Forum and in Kyiv at a seminar with Polish business representatives whom I informed about the BOC tools for protecting rights of foreign investors in Ukraine. I participated in "Marupol-2030. Great Investment Opportunities" conference at the invitation of Mariupol City Council and the Office of Simple Decisions and Results, where I discussed problems of entrepreneurs as well as prospects for improving the business climate in the region with business community and local authorities.

We have launched the autumn season of practical webinars for business and lawyers with partners – the Committee on Customs and Tax Law and the Committee on Land, Agricultural and Environmental Law of the Ukrainian National Bar Association. Next in line are events with the American Chamber of Commerce in Ukraine registration for which is already open.
