The Business Ombudsman Council is a standing consulting and advisory body of the Cabinet of Ministers of Ukraine. The BOC has been established to contribute to the transparency of the activities of state authorities, businesses within the scope of their administration, preventing corruption and/or other violations of legitimate interests of businesses. It consists of BO and two DBOs and is supported by a secretariat. An Investigator is part of the secretariat and reports to a Deputy Business Ombudsman.

On June 23, 2022, the leaders of 27 EU member states decided to grant Ukraine the status of a candidate for membership in the European Union. Geopolitical conditions require Ukraine to speed up the adaptation of legislation and practice to EU standards, and the Business Ombudsman Council needs professional support in matters of practical application of European legislation.

Within this context, the EU Legislation Lawyer will be instrumental in navigating the complex landscape of EU legislative adaptation, contributing to the Business Ombudsman Council's mission of enhancing transparency, preventing corruption, and aligning with EU standards in the dynamic geopolitical context of Ukraine's candidacy for EU membership.

The EU Legislation Lawyer fully supports the BO and DBOs in building and maintaining relationships with the relevant national, regional and local authorities. The Investigator also contributes to policy dialogue with the relevant national authorities, delivers presentations to external stakeholders, and contributes to the preparations for international conferences and workshops.

The EU Legislation Lawyer will play a crucial role in providing legal expertise and support to the Business Ombudsman Council in the implementation and compliance of European Union (EU) legislation with focus on public administration, administrative procedures, and decentralization. This position requires a deep understanding of EU laws and regulations, excellent analytical skills, and the ability to collaborate with internal stakeholders and external partners.
